Day 1 – Monday, March 10: Depart U.S.A.

Tour members meet for our flight to Israel. After dinner is served, it's time to sit back, relax, and enjoy the on-board entertainment to prepare for this exciting adventure of a lifetime.

Day 2 – Tuesday, March 11: Arrive in Tel Aviv, Netanya

In Tel Aviv, we proceed through customs and security to meet our agent who assists us to our motor coach. Then we meet our tour guide and leave the airport. Time permitting, we will have a stop in Jaffa. We then arrive in Netanya for dinner and overnight.

Day 3 – Wednesday, March 12: Caesarea Maritima, Mount Carmel, Megiddo, Mount Tabor, Nazareth, Sea of Galilee

This morning we depart for Caesarea Maritima, Herod's seaside palace and hippodrome; Mount Carmel, where Elijah confronted the prophets of Baal (1 Kings 18); and then to Megiddo. Time permitting, we will stop at the Druze Village for a short lunch break (not included). We continue to Mount Tabor in the Jezreel Valley, where the Israelite tribes gathered in the days of Deborah and Barak led the Israelite charge of 10,000 men against Sisera's army. We end our day visiting Nazareth, Jesus' childhood home. We then arrive for dinner and overnight near the Sea of Galilee.

**Day 4 – Thursday, March 13: Mount of Beatitudes, Magdala, Capernaum, Boat Ride, Jordan River**

Nothing compares to watching the sun rise over

the Sea of Galilee! We begin today reflecting and worshiping at the Mount of Beatitudes. From there we visit Magdala where a first century synagogue and a complete first century city have been discovered. It is traditionally held to be the birthplace of Mary Magdalene. We then head to Capernaum, the ancient fishing village of Peter's home and Jesus' base for His early ministry. For those interested, our lunch stop includes the option of ordering the special St. Peter's Fish (not included). After lunch, we board a replica wooden "Jesus Boat" to set sail on the Sea of Galilee before making our way to the Jordan River. Dinner and overnight are back at the Sea of Galilee.

**Day 5 – Friday, March 14: Caesarea Philippi, Tel Dan, Hula Lake**

After breakfast, we head to Caesarea Philippi where Peter confessed, "You are the Messiah, the Son of the living God" (Matthew 16:13-16). We embark on a short hike to Tel Dan, an impressive archaeological site with unique remains of Canaanite and Israelite cities and a Biblical High Place (altar) of Jeroboam. We conclude our day at Hula Lake - one of the world's most important natural bird sanctuaries - with a safari-type truck ride through the bird fields. Dinner and overnight are back at the Sea of Galilee.

Day 6 – Saturday, March 15: Gideon Springs, Qumran, Beit Shean, Dead Sea for Swim/Float, Jerusalem

We start our day at the beautiful Gideon Springs where God narrowed Gideon's soldiers to 300. Then we drive to Qumran, the settlement of the

Essenes (the first century sect who authored the Dead Sea Scrolls). Next, we visit Beit Shean, one of the best-preserved Decapolis Roman cities where King Saul and his sons' bodies were hung from the city walls after being defeated by the Philistines (1 Samuel 31:10-12). We finish our day with a relaxing swim/float on the Dead Sea. Finally, we ascend to the majestic city of Jerusalem in time for dinner and overnight. "I was glad when they said to me, 'Let us go to the house of the Lord.' Our feet are standing within your gates, O Jerusalem" (Psalm 122:1-2).



Day 7 – Sunday, March 16: Bethlehem, Mount of Olives, Palm Sunday Road, Garden of Gethsemane, Holy Sepulchre, Western Wall

We begin today on the beautiful Mt. of Olives to behold the famous, breathtaking panorama of the Holy City. Our pilgrimage descends down Old Palm Sunday Road to the ancient olive grove at the Garden of Gethsemane for a special time of prayer and meditation. We continue to the Church of the Agony (Church of All Nations) where tradition says Jesus prayed before his arrest. We continue to the Church of the Holy Sepulchre. Beyond the wall lies the 35-acre temple area purchased by King David (2 Samuel 24:18-25), which is called the Temple Mount (the third holiest shrine in Islam, housing both the El-Aqsa Mosque and the magnificent Dome of the Rock). From there we proceed to the Western (Wailing) Wall, the holiest site in Judaism. We finish our day with a visit to Bethlehem (Church of the Nativity and Shepherds' Field). Dinner and overnight are back in Jerusalem.

Day 8 – Monday, March 17: City of David, Hezekiah's Tunnel, Pool of Siloam, Upper Room, Garden Tomb, Machane Yehuda Food Market

After breakfast, we visit the City of David, and then go on a short walk through Hezekiah's Tunnel (conditions permitting). Be sure to bring a flashlight and water shoes to walk through the tunnel. Anyone wanting to stay dry can walk through Hezekiah's shaft. If time permits, we will visit the newly excavated Pool of Siloam. We then venture into the Upper Room where Jesus instituted the Lord's Supper. We end our tour day with worship and communion at Golgotha and the Garden Tomb. Then we have free time in the colorful Machane Yehuda Food Market where traditional Israeli food and an infinite variety of spices greet us from every booth. Dinner and overnight in Jerusalem.

Day 9 – Tuesday, March 18: Tel Azekah, Elah Valley, Beit Guvrin, Jaffa, Farewell Dinner

After breakfast, we drive to Tel Azekah overlooking the Elah Valley where David dueled with Goliath. References to Azekah first appear in Joshua's campaign of the city of Gibeon where he chased the five Amorite kings down to Azekah where the Israelites slew the Amorites (Joshua 10:10-11). We then drive to Beit Guvrin, a beautiful national park with numerous bell-shaped caves and incredible underground spaces to explore. We then head to Jaffa for our Farewell Dinner before returning to Jerusalem for overnight.

Day 10 – Wednesday, March 19: Transfer to Ben Gurion Airport, Departure Flight, Arrive in U.S.A.

We transfer to the airport and arrive back in the U.S.A, taking home wonderful memories of the Old and New Testament, a renewal of our faith, and a greater understanding of the life of our Lord.

Deviations by the passenger, from the group's scheduled flights, could result in different routings/air carriers. Airline changes, if allowable, made by the passenger after final payment has been made, may incur additional fees.

FLIGHT TIMES:

All flight times are subject to change by the airlines without advance notice. *imagine* is not responsible for such changes or delays and does not reimburse expenses resulting from such delays. If making your own flight arrangements to a departure city or any other portion of your trip, we recommend you purchase a ticket which can be changed without large penalties. All passengers are responsible for reconfirming their flights with the airline 24 hours prior to departure.

PASSPORT:

Each passenger is responsible for making sure that they have a **valid passport that has an expiration date at least six months after the date of return from their trip.** A copy of your valid passport must be submitted to our office by 100 days prior to departure.

VISAS:

Applicable visas will be obtained by *imagine* for U.S. and Canadian Citizens only. All passengers who do not carry U.S. or Canadian Passports will be responsible for obtaining visas to the countries they are visiting. *imagine* is not responsible for non-U.S. & Canadian Passport holders.

TRIP RESCHEDULING:

imagine and/or Trip leader reserve the right to re-schedule the dates of the Trip to future dates TBD due to governmental action, pandemic, or other circumstances beyond their control. Should that occur, all travelers will be rebooked for the new dates. Travelers unable to travel on the new dates may cancel their participation and will be assessed a cancellation fee of up to \$300 per person, plus any additional penalties/fees imposed by ground operator(s), airlines, or other vendors. Travelers can transfer to another available tour up to one year from their original departure date.

CANCELLATION FEES:

Any passenger cancelling from the day of registration to 100 days prior to departure will be charged a **\$300 non-refundable administrative fee** per person plus any airline penalties, if applicable. You will also be charged a single room fee if your cancellation forces your roommate into a single room from 75 days prior until the date of departure.

The following charges also apply: 99-75 days = **\$500**; 74-55 days = **\$1950**; 54-41 days = **75% of total cost**; 40 days to day of departure = **100% of total cost. All cancellations must be received in writing. On or after the day of departure there is no refund for any services not used. We strongly recommend you purchase travel insurance.** If *imagine* cancels the tour due to lack of participation, there will be a charge of \$200 deducted from the amount refunded to each passenger for administrative fees plus any airline penalties if applicable. No changes may be made to the tour within 70-days of departure, as the tour is **officially closed.**
