Day 1 – Thursday, October 9: Depart U.S.A.

Embark upon your journey with an overnight flight to Athens. Prepare yourself for a life-changing experience and get some rest on the flight. Tomorrow you will be walking where the apostle Paul walked!

Day 2 – Friday, October 10: Arrival in Athens, Greece

We arrive in Athens mid-afternoon, where we are met by our representative and transferred to our hotel in Athens. Dinner and overnight at our hotel.

Day 3 – Saturday, October 11: Athens: Acropolis & Mars Hill - Embark on your 7-Night Cruise

In the morning, we begin with a guided tour of the miraculous city of Athens! We'll follow our guide as we visit the world-renowned Acropolis, to see the Propylea, the Erechtheum, and the Parthenon. We visit Mars Hill, where Paul delivered his speech on the "Unknown God." Then we see the Agora, the ancient center of economic and public life for the city, where Paul preached to the skeptical Athenians. During our bus tour, we also see Constitution Square with the House of Parliament and the Tomb of the Unknown Soldier, along with the Temple of Zues, the Old Olympic Stadium, and the Neoclassical Buildings of Athens. Come the afternoon, we have a short drive to the port of Lavrion where we will embark on our "floating hotel", the Celestial Journey, which will be our home for the next 7-nights!

**Day 4 – Sunday, October 12: Thessaloniki**

In the morning, we arrive in Thessaloniki where we'll start our tour seeing the landmark of the city: the White Tower. Thessaloniki is the city where Paul was received by Jason. We'll visit the House of Jason where Paul lived, and the Agora where Paul preached the Word of God

here until he was rushed out of the city. We return to our ship for dinner and overnight.

Day 5 – Monday, October 13: Kusadasi to Ephesus


Today we arrive at Kusadasi (Turkey), where we experience a tour of Ephesus, one of the Seven Churches of Revelation. In ancient days, Ephesus was a bustling port town of 250,000, graced with wide, colonnade bordered streets. Paul's first visit to Ephesus was brief-during his second missionary tour. His second visit lasted about three years-during his third missionary tour. We'll walk the marble-paved street with grooves made by chariot wheels. Here we see the Fountain of Trojan, the Library of Celsus, and the Great Theatre. We will also visit the House of the Virgin Mary and time permitting, we may even visit the Basilica of St. John. Afterwards, we continue to Miletus; home of ancient philosopher Thales, one of the fathers of Greek geometry, astronomy, and philosophy. It was here, in the first Christian century, that Paul, on his third missionary journey, called for the Ephesian elders and preached a powerful message to them. It was also here that Paul left his friend Trophimus, who was too ill to continue. We return to our ship for dinner and overnight.

Day 6 – Tuesday, October 14: Crete to Heraklion

This morning, we arrive in Crete and make port in the city of Heraklion. Crete is the largest and most rugged of the Greek Islands. This is also the ancient home of the great Minoans, and the mythological god, Zeus. After a short ride through the town of Heraklion, we arrive at the Knossos excavations. Here, Sir Arthur Evans' archaeological discoveries revealed a civilization dating back to 4000 B.C., when a great empire flourished on the island of Crete. Paul left Titus in Crete and gave him instructions on appointing church leaders in the towns (Titus 1:5ff). In ancient Greek mythology, it was said that Knossos Palace was home to a great labyrinth which housed the mighty Minotaur. This is also thought to be the site of the tale where Daedalus and Icarus formed wings of wax and feathers to escape their imprisonment before Icarus flew too close to the sun. We once again returned to our ship for dinner and overnight.

Day 7 – Wednesday, October 15: Santorini

We awaken upon the beautiful city of Santorini this morning! Santorini is considered by many to be the most spectacular of all the Greek Islands. Here we can ascend the city via cable car (not included) or if you're feeling adventurous, you can scale the pathway via donkey (not included). Santorini, or what remains, was devastated by

a volcanic eruption in the 16th Century B.C. According to Plato's description of the mythological city of Atlantis, many signs point to Santorini which is thought to be the home of the lost mythical empire. While the true location of Atlantis is unknown, and many believe it never existed, Santorini is still home to some of the most majestic views in all the Mediterranean. Featuring Greece's picturesque white buildings topped with blue domes, we'll have the opportunity to explore this beautiful island at our leisure. We return to the ship for dinner and overnight.



Day 8 – Thursday, October 16: Mykonos

Known as the "Island of Winds", we arrive this morning in Mykonos. Here, we can stroll the charming walkways through a maze of white-washed buildings, explore the local shops, and indulge in one of the many culinary delights. Perched atop the hillside are the windmills dating to the 16th century just above the city. With no set itinerary, we're free to explore the island at our leisure. In Greek mythology, Mykonos is mentioned in a various number of stories and grand tales, ranging from the island being formed from the petrification of a giant, to being the battle grounds of the false god, Zeus against the Titans. According to history, Mykonos is where the earliest amphora was discovered. This evening, we return to our ship for dinner and overnight.

Day 9 – Friday, October 17: Milos

Today we sail to the last of our island destinations, Milos. Many find Milos to be the most exotic of the islands in the Aegean Sea, shaped by its volcanic past and covered in beaches of red, pink, and orange. Home to the Catacombs of Milos, this is considered to be one of the most important early Christian monuments in all of Greece. Dating somewhere between the 1st and

5th century, these catacombs were home to a place of worship and refuge amongst early Christians. Many scholars also believe Milos to be the island where Paul had shipwrecked on his way to Crete from Athens. While the gospel does not explicitly list Milos as this site, it is heavily considered to be amongst the Christian community. We return to our ship for our final dinner and overnight, as we sail back to Athens in the morning.

Day 10 – Saturday, October 18: Disembark in Lavrion, Corinth, Athens

Our ship returns early this morning to the port of Lavrion (Athens) where we disembark. From here, we begin our day with a trip to Ancient Corinth. This was the once glorious city near the Isthmus, where Paul met Aquilla and Priscilla and spent a year and a half preaching the Gospel. Here we visit the Archaeological Museum, the Forum, the Temples, and the famous Bema, where Paul stood before Gallio, accused by the Jews of Corinth. The afternoon is at leisure to explore Athens on your own. This evening, we check in to our hotel in Athens for a Farewell Dinner and overnight.

Day 11 – Sunday, October 19: Athens, Return to U.S.A.

In the morning, we transfer to the Athens Airport for our return flight back to the U.S.A. As we fly back home, we reflect on our new insight into Paul's life and teachings.

If one is not available or if you request a single room, there will be a **single room supplement charge: \$1,595 for basic itinerary. We highly recommend securing a roommate, as single rooms are very limited on the cruise.**

ITINERARY & CHANGES:

Because airlines often change flight schedules after brochures are printed, *imagine* reserves the right to shorten or lengthen the itinerary accordingly. You will be notified in writing when possible. If itinerary changes necessitate extra overnights, you will be charged \$195 per night/per person (single rooms/cabins \$245/night). Meals for extra nights are not included. **Any changes and/or deviations from the program and/ or departure city listed, by the passenger, must be provided in writing to imagine no later than 100-days prior to departure and any extra costs incurred will be billed to the passenger.** All deviations are subject to a standard fee of \$150 plus any applicable airline fees. **All tours are final at 90-days prior to departure. No changes and/or additions may be made to the tour after that time.**

LAND ONLY:

Land Only price is \$4,695 per person. Pricing does not include international flights. Land Only passengers may be responsible for transfers and/or additional overnights incurred by booking their own flights. We recommend you purchase a ticket which can be changed without large penalties, as the group's flights may change. Passengers changing from the regular tour to Land Only after 120 days prior to departure will be charged a fee of \$150 per person.

AIRLINE TICKETS:

In order to keep prices low, *imagine* does not guarantee you will be on the most direct flights to your final destination. *imagine* also does not guarantee the group will be on the same flights, particularly if registering 120 days prior to departure. Flight routings are chosen by the airlines and not *imagine*. Airline tickets cannot be changed or refunded once issued. Air transportation to/from your destination will be economy class aboard IATA and ARC carriers utilizing APEX or SUPER APEX non-refundable, non-amendable tickets for groups of 10 or more flying together for entire itinerary. *imagine* is unable to use individual

frequent flyer points to upgrade or accept them as partial payment for air transportation. Deviations by the passenger, from the group's scheduled flights, could result in different routings/air carriers. Airline changes, if allowable, made by the passenger after final payment has been made, may incur additional fees.

FLIGHT TIMES:

All flight times are subject to change by the airlines without advance notice. *imagine* is not responsible for such changes or delays and does not reimburse expenses resulting from such delays. If making your own flight arrangements to a departure city or any other portion of your trip, we recommend you purchase a ticket which can be changed without large penalties. All passengers are responsible for reconfirming their flights with the airline 24 hours prior to departure.

PASSPORT:

Each passenger is responsible for making sure that they have a **valid passport that has an expiration date at least six months after the date of return from their trip.** A copy of your valid passport must be submitted to our office by 120 days prior to departure.

VISAS:

Applicable visas will be obtained by *imagine* for U.S. and Canadian Citizens only with the exception of travel to Turkey. All passengers who do not carry U.S. or Canadian Passports will be responsible for obtaining visas to the countries they are visiting. *imagine* is not responsible for non-U.S. & Canadian Passport holders.

TRIP RESCHEDULING:

imagine and/or Trip leader reserve the right to re-schedule the dates of the Trip to future dates TBD due to governmental action, pandemic, or other circumstances beyond their control. Should that occur, all travelers will be rebooked for the new dates. Travelers unable to travel on the new dates may cancel their participation and will be assessed a cancellation fee of up to \$500 per person, plus any additional penalties/fees imposed by ground operator(s), airlines, or other vendors. Travelers can transfer to another available tour up to one year from their original departure date.

CANCELLATION FEES:

Any passenger cancelling from the day of registration to 121 days prior to departure will be charged a **\$500 non-refundable administrative fee** per person plus any airline penalties, if applicable. You will also be charged a single room fee if your cancellation forces your roommate into a single room from 75 days prior until the date of departure. The following charges also apply: 120-95 days = **\$1500**; 94-75 days = **\$2450**; 74 days to day of departure = **100% of total cost. All Cancellations must be received in writing. On or after the day of departure there is no refund for any services not used. We strongly recommend you purchase travel insurance.**

If *imagine* cancels the tour due to lack of participation, there will be a charge of \$250 deducted from the amount refunded to each passenger for administrative fees plus any airline penalties if applicable. No changes may be made to the tour within 90-days of departure, as the tour is **officially closed.**

This represents the entire agreement between the passenger and his agent, the travel agent, the tour host, and the tour operator. You understand and freely accept these risks, and you generally and specifically release and hold harmless *imagine* and their officers, agents and employees from any liability and any claims for (i) any physical, mental, emotional or other injuries whatsoever that you may sustain related to this tour; (ii) delays, damages, illness, injuries or death, or for the loss of or damage to property, from any cause (including negligence) and however occurring; and (iii) any accident, illness, injury, damage, sickness, loss of personal property, delay, or other injury or claim of any kind related to or arising from strikes, armed conflicts, social or labor unrest or strikes/work stoppages, war or acts of war, terrorism or terrorist acts, acts of God, mechanical or construction failures or difficulties, diseases, local laws or acts of local or government authorities, criminal acts, weather or climatic conditions, volcanic eruption, earthquake, disruption of advertised schedules, refusal of visas, or any other causes beyond their direct control.
